Busking (Street Performance) Permit Conditions:

- Busking is permitted on the following dates and times:
Fridays, June 22-July 20, from 5:00—10:00 pm.
Saturday, July 28, from 9:00 am—10:00 pm; Sunday, July 29, 9:00 am—4:00 pm
Permit holders will be notified of other times performance opportunities as they occur.
- Busking outside of above dates and times is not permitted unless agreement is obtained from surrounding premises or a specific exemption applies.
- Buskers using loud instruments (ie: bag pipes or drums) must obtain permission from surrounding premises. Note: this is not a license to create excessive noise.
- If Greeley Downtown or City of Greeley receives justified noise or obstruction complaints related to the activities of a busker the permit holder will be asked to discontinue performing. Failure to comply with the request may result in busker being asked to leave the downtown area.
- The use of amplifiers is prohibited without proper noise amplification permit from the City of Greeley.
- Busking is only allowed in the areas outlined on the accompanying map. Areas indicated are open to buskers by property/business owner permission, and available by first-come-first-served basis.
- Permits will not be issued to anyone under age 14 without the consent of a parent or caregiver. Proof of age may be requested.
- The maximum number in any one group is four unless a specific exemption is provided.
- Permits are valid for a maximum of one year from the date of issue.
- Buskers must comply with all other relevant City of Greeley ordinances and laws.
- Failure to observe the conditions of the Busking Permit may result in cancellation of this permit.
- Buskers may accept tips from audience members, but may not sell any wares without the proper downtown vendor permit, available through the City of Greeley Finance Department at 1000 10th Street.
- Greeley Downtown Development Authority and City of Greeley reserves the right to ask any busker to discontinue performance if deemed inappropriate. Buskers are encouraged to keep all performances family-appropriate.

Once your application is approved, a permit will be sent to you along with a map of areas busking is allowed.

I confirm with the best of my knowledge the information provided above is correct. I declare that I am familiar with the terms and conditions that apply to this permit and agree to abide by them. I acknowledge that I will receive no compensation for street performances, aside from tips. **Risk & Liability:** I hereby release and agree to hold harmless the Downtown Development Authority and the City of Greeley from any damage to the undersigned's property or any personal injury which he/she or fellow performers, as listed above, may sustain while busking in the Greeley Downtown area.
